13(b)	<p>The only correct answer is C (to prevent deterioration by fungal activity)</p> <p><i>A is incorrect because to prevent deterioration of the food which in the long run maintains the taste is not the same as improving the taste of food</i></p> <p><i>B is incorrect because this is not the reason for the addition of buffers to food</i></p> <p><i>D is incorrect because to prevent deterioration of the food which in the long run maintains the colour and appearance of food this is not the same as enhancing these qualities</i></p>	(1)

13(c)	<p>The only correct answer is C (the pH will decrease due to the equilibria shifting to the right)</p> <p><i>A is incorrect because exercise produces CO₂ so the equilibria shift to the right</i></p> <p><i>B is incorrect because the increase in carbon dioxide produced will shift the equilibria to the right</i></p> <p><i>D is incorrect because the definition of buffers does not state that the pH is always kept constant but varies only slightly if small amounts of acid or base are added</i></p>	(1)

14	<p>The only correct answer is D (NO₂(g))</p> <p><i>A is incorrect because mercury has a metallic structure with some order that results in its entropy being lower than most gases</i></p> <p><i>B is incorrect because water has some order in its structure with hydrogen bonding and so its entropy is lower than most gases</i></p> <p><i>C is incorrect because it is a simpler gaseous molecule than NO₂</i></p>	(1)
